## St. Anne's Financial Position


An overview of the finances of the church are given in the pie charts over the page. We provide this so that we are all aware of the costs of running our church.

- As you can see our biggest expenditure is the parish share—this is the
  amount given to the diocese for clergy pay, housing and pensions and
  diocesan running costs. This has increased by £3,800 this year and
  likely a similar amount in 2025.
- Our parish centre brings in letting income which pays for it's expenses and makes a small profit.
- We continue to give to mission agencies in this country and abroad and also to the support of our church school.
- We seek to be wise with our resources and use the parish buying scheme to access discount green energy for our church.
- We put out to tender the grass cutting and gardening of the churchyard to get the best value.
- A big source of revenue to the church is the GiftAid we can recover from any donations given from those who pay income tax. Please consider this if you are eligible.

A detailed breakdown of the expenses is available upon request or on the notice board at the back of church.

Though we have many ways of money coming to the church, our regular giving is the most reliable. We do depend on the godly generosity of our members to support all that goes on at St. Anne's.

## **Income and Expenditure 2023**



We rejoice every year that the Lord provides and our outgoings and income over 2023 are almost the same. But still it almost costs £2,000 per week to run St. Anne's.

### **How Can I Respond?**

The Bible tells us to pray, consider and to give.

The running and financing of our church is our responsibility. Together our giving can make a big difference.

## **Regular Giving**

If you haven't already, think about regular giving to the church by using standing orders. Forms are available at the back of church with St. Anne's bank details also at the end of this pamphlet.

If you already give regularly please consider increasing your standing order, maybe in line with your income. Even a modest increase can accumulate over the year.

## Being wise in our giving

If you pay any income tax this can be reclaimed from the government GiftAid scheme. Please see the forms at the back of church for details.

Many of us no longer carry much cash on us, if you would like to give additional gifts, the machine is available at every service.

## **Bequests**

Over the years the church has benefitted from gifts given in wills. Please consider St. Anne's as a beneficiary if you are writing a will.
